1 Must have a BSA National Camp School Shooting Sports Director/NRA certified Firearms Instructor/Range Safety Officer on site to use Shotgun/Rifle ranges and firearms. Must have certificates on file with the Great Smoky Mountain Council office and be approved by the GSMC Shooting Sports Staff.

2 Must have a BSA National Camp School Shooting Sports Director or a Level 1 Archery Instructor/Range Safety Officer on site to use the Archery range and equipment.

1. Applications must be submitted no later than 4 weeks prior to planned activity in order to secure or approve appropriate personnel responsible for range operations.
2. Firearms used at the Camp Buck Toms Ranges must be inspected and approved by the Shooting Sports Coordinator prior to their use at Camp. It is recommended that the Great Smoky Mountain Council owned firearms be used in all shooting activities. They have been inspected and are maintained for this purpose. They are also appropriately sized and suited for scouts of varying age and size.
3. In the event that personal firearms are used, they shall be no larger than .22 caliber for rifles and 12 gauge for shotguns. Ammunition shall not exceed 22 long rifle cartridges and #7 shot shotgun shells and must be approved prior to their use at Camp Buck Toms..
4. Only camp supplied ammunition shall be used in the camp owned firearms.
5. All Camp owned firearms shall be cleaned and inspected prior to departure from camp.
6. Units are responsible for cleanup of all ranges after use. Spent shells shall be picked up and properly disposed of. Shooting areas shall be swept and cleared of broken clay targets.
